FREE ONGOING SEARCHES & HOLDS

RCI Platinum members have the ability to put their upcoming vacation on hold or open an ongoing search **without paying the associated fee up front.**



FREE POINTS TRANSFERS

RCI Platinum members may transfer Points from their account to another eligible RCI Points member's account **free of charge - no limits!** Standard RCI® members pay a fee for every Points Transfer.

UPGRADES & EXTRAS

More flexibility, more time, more options.

RCI Platinum® members get more! RCI Points® Platinum members who purchase Points Extension **enjoy two additional Use Years to exchange extended points** - twice as long as standard RCI® members who purchase Points Extension. RCI Platinum members may also use **50% of their annual Points allocation in the RCI® Points Partner program**, as opposed to 33% for standard RCI members. RCI Platinum members also have the opportunity to receive **complimentary unit upgrades and resort changes** for exchanges, where available, without paying the fee which applies to standard RCI® members.





COMPLIMENTARY UPGRADES & CHANGES

RCI Platinum members with a confirmed Exchange vacation have the opportunity to request a unit upgrade at the same resort. Unit upgrades are units with at least one additional bedroom and at least the same size kitchen and number of bathrooms as the unit for the confirmed exchange. If available, RCI will provide a unit upgrade no sooner than 14 days prior to the check-in date of the reservation.

RCI Platinum members may also request to change a resort selected in a previously confirmed exchange beginning 14 days prior, and up to 3 days before, the start date of the previously confirmed exchange. The member may select up to a maximum of 5 possible substitute resorts which must be within the same geographic region as the resort of the previously confirmed exchange and the unit at the requested resort must be the same size or larger than the previously confirmed exchange.

No requests are permitted for exchanges at all-inclusive resorts or home resorts, and requests for resort changes are not available for original bookings at LATAM resorts. Terms, conditions and other exclusions also apply.

INCREASED RCI® POINTS PARTNER CAP

RCI Platinum® members who have access to the RCI® Points Partner program may use in each calendar year, the greater of: (a) 50% of their annual Point allocation up to a maximum of 250,000 Points or (b) 40,000 Points. This is compared to standard RCI members who may use 33% of their annual allotment or 25,000 Points, whichever is greater.

POINTS EXTENSION - ADDITIONAL USE-YEAR

RCI Platinum members, who are RCI Points members, are **eligible to extend their Points for TWO additional Use Years when they pay the applicable fee.** Standard RCI Points members pay the same fee for one additional Use Year. RCI Platinum members also earn Savings Dollars when they purchase the Points Extension product.
